Dining Dollar Funds

Dining Dollar Rollover: Any remaining 2024-2025 Dining Dollar balances will expire at 11:59PM on Saturday, 12/13/2025 unless Student has selected a Dining Plan for 2025-26 or if no longer living on campus, purchased a Triton Community Dining Plan via TritonPay by 12/13/2025.

Dining funds are removed for any housing contracts approved for early termination mid-academic year for reasons other than a campus housing shut down. Unused dining funds due to early termination are not refundable. The Dining Plan cannot be changed to a lesser value, transferred, dropped, or refunded.

Over Usage of Dining Plan Funds:

Dining Dollars and Triton Cash associated with your housing contract are intended to support your dining needs throughout the full academic year. If you are approved for an early move-out or contract termination, your housing and dining costs will be prorated to reflect your approved move-out date. If you have used more Dining Dollars or Triton Cash than what is allocated for that period (based on a daily rate), you may be charged for the overuse. Please contact Triton Card Account Services to understand how early termination may impact your Dining Plan balance and potential charges.


No Proration Period
